Knowing these facts, I nevertheless wish to participate in certain activities at Dreamswept Farm, Inc., or with Tamea C. Denault or the MountainWind Vaulters involving horse riding.

In consideration of your acceptance of this form, and as part payment for the right to participate in horse riding activities, for myself, my heirs, assigns, and personal representatives, individually, jointly, and severally, fully and forever, I hereby assume all risks above named and hold harmless, indemnify, release, defend, and discharge Dreamswept Farm, Inc., Tamea C. Denault, the MountainWind Vaulters, respectively, their agents, servants, employees, partners, attorneys, successors, administrators, executors, assigns, heirs, personal representatives, and all other persons associated with them or in boarding and competition or pleasure horse riding involved herein, from any and all actions, debts, claims, or demands of whatsoever kind or nature which may arise out of or in connection with my participation in any activities involving or related to horse riding arranged for me at Dreamswept Farm, Inc., or by Tamea C. ## **Directions from Seattle:**

(please use these directions, GPS or mapquest/google will not get you to Dreamswept Farm)

Take I5 to I90

Exit onto I90 East toward Spokane

Exit in Spokane on State Route 395 North  
toward Colville (Division St exit)

It will be about 2 hours 20 minutes (96 miles) to Kettle Falls

Go through Deer Park, Chewelah, Colville, Kettle Falls

Go over the Columbia river/Lake Roosevelt

the road will y to right (stay on SR 395)

Go about 5 miles from y (Barney's junction)

Slow down when you see the green county shop sign

Go around sharp corner at bottom of hill

Turn left onto Deadman Creek Rd

(if you pass DJ's Second Hand store you have  
gone one block too far)

Go 3.8 miles and turn right onto

Jackknife Lookout Rd

Go 1.9 miles to Dreamswept Farm entrance

There will be a sign

Turn right into driveway

Barn will be the second right turn.

It takes about 6 1/2 hours from Tacoma

Rout 2 is scenic and very beautiful, but slow
